# Labor Ready:

A question was asked about coaches and a possible stipend for driving to sporting events-Ted stated that this compensation is part of the coaches' contract. Zia stated that the buses are costing more than originally expected. Nick explained the money throughout the year would be compromised and we are in need of doing a capital campaign to assist with expenses this year. Adrienne stated that it will be a couple of months before the expenses of the facility settles down. Nick said that we should get a big sales tax reimbursement back this year.

**Motion:** A motion was made by Zia to approve \$40,000 to hire bus drivers for the new buses and bus routes. Adrienne seconded. Vote was unanimous. **Motion was carried.**
